# **Privacy Policy**

Protecting your private information is our priority. This Statement of Privacy applies to www.reachyourheartout.com and Reach Your Heart Out, PLLC and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Reach Your Heart Out, PLLC include www.reachyourheartout.com and Reach Your Heart Out. The Reach Your Heart Out website is a counseling and consulting services site. By using the Reach Your Heart Out website, you consent to the data practices described in this statement.

### **Collection of your Personal Information**

Please keep in mind that if you directly disclose personally identifiable information or personally sensitive data through Reach Your Heart Out's public message boards, this information may be collected and used by others.

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services available on the Site. ## **Sharing Information with Third Parties**
